Waste Disposal Services Rates

As of March 19, 2020, the rate schedules for Waste Hauler Disposal are as follows:

Annual Permit Fee Per Truck: \$100

Disposal Rate: \$0.10 per Gallon

Minimum Load Rate: \$50.00 (Less than 500 Gallons)

Late Fee: 10% of monthly billing or minimum of \$10/billing – whichever is greater

These Rates are subject to annual review by the HCUA Board of Directors.
