Mayor Andrew "Fofo" Gilich opened the floor for public comments.

Mr. Al Gombos explained that the D'Iberville City Council expressed concerns during a D'Iberville City Council Meeting regarding debris flying out onto the roads from uncovered trash containers hauled by garbage trucks. It has been determined that the garbage trucks with unsecured loads are dumpster haulers and not residential haulers and the haulers are sometimes from neighboring counties. Mr. Gombos expressed the need for a community approach and joint resolution to hold all haulers accountable for debris liter. There will be more discussion in the future and suggestions are welcomed by HCUA Board Members for a resolution.

#### E2c. Award Clam Hoist

## F. Executive Director's Report

Mr. John Wilson explained that the Long Beach Project, Phase II, at the east end, is in final stages. Long Beach Project, Phase I, is under way at the west half of Menge Avenue and lanes may be closed to one lane with traffic control. Road equipment on the road will be a factor that determines lane closures.

### G. Executive Session

There was no need for Executive Session.

Mr. James Simpson noted that discussion on the S-14 litigation continues. There was a delay in progress due to positive cases of COVID. There are depositions scheduled over the next six weeks.

Supervisor Marlin Ladner requested and an update on the "Notice for Dolan Park".

Mr. Simpson explained that he spoke to Mr. John Wilson and attempted to call Mr. Tim Holliman. Mr. Holliman has noted that the notice is a defective tort claims notice. Dolan is a customer of HCUA currently with a neighborhood system. HCUA is a separate entity and there is no action to be taken by HCUA. In the future, it may be required by Harrison County, not HCUA, to install a line. The lagoon does not currently exist, but Dolan previously had a discharge permit for the lagoon.

Supervisor Marlin Ladner requested HCUA to provide an estimate for services in the event Harrison County is required to install a line.
