E2a. O&M Contract Retainage/Benchmark-Review and Release

Mr. John Wilson requested approval for H2O Innovations, O&M Contract Retainage/Benchmark - Review and Release.

John responded to Supervisor Ladner's question regarding item #9 and explained two sand filters have already received a complete rehab from top to bottom, but the systems are not going to get twenty years of life, as in the past.

John added two more sand filters will be completed as rehab systems, in 2021 Fiscal Year. HCUA is working with City of Gulfport to assist with the process of applying for SRF Funding eligibility. The funding is to replace sand filters and uv system. John noted the system will cost between seven million to eight million dollars.

Mayor Billy Hewes requested clarification on the request to change definition wording of Benchmark, from "Report Major Equipment Failures" to "Report equipment failures involving safety, process or compliance", and whether or not there is a category. Mr. Wilson explained the request was for one new specific benchmark, to change language to define minor versus major mechanical problems. Mr. Wilson advised he would return at a later date and present changes in the existing and new benchmarks and noted changes of benchmark are working within the scope of the contract.
