Ms. Cindy Breaux explained that the increase in chemicals is due to order dates versus receiving dates of the product. The IT category will have a decrease adjustment of \$8,900.00 and the \$8,900.00 will be entered in the Tire Expense category. The Admin category requires a decrease adjustment, and the adjustment will be split in the Wastewater and Water categories. The City Works annual program cost is an annual payment and the budget appears high on the report, but the numbers will average out on the report during the rest of the FY22 period.

Auditors have completed the FY21 Audit and are currently working on the preliminary report. Once the preliminary report is received, the Management, Discussion and Analysis Report will be prepared and presented to the Board.
