Ms. Tami Blackwell with The Focus Group introduced Chelsea Payne, HCUA's contact person for marketing with The Focus Group. Ms. Blackwell explained that organic (free) posts to HCUA Facebook page reached over 5,800 in November 2022. Facebook temporary stopped HCUA's ad campaign due to the wording of "recycle" and the requirement that there be a visible standard disclaimer attached to the ads. The issue was resolved, and the campaign continued with over 42,000 impressions and there were 1,049 clicks at a rate of \$.29 cents cost per click. with a standard industry average of \$1.72 per click.

The new pipe installed has been in operation. Project will close-out soon (December 23, 2022) and a Summary Change Order and Close Out Documents will be presented to finalize project. Supervisor Marlin Ladner requested clarification on the status of Menge Avenue work and who determines the subcontractor for paving. Mr. Wilson explained that pipe has been installed and pressure tested. Contractor determines subcontractor for paving and the project is ready for land shapers.
