Ms. Tori Martinez of The Focus Group presented the Facebook and website stats. Organic Social Media engagement is up 733% from last year, there were over 13,000 post engagements, up 413% over last year, and reactions are up 589%. The website's most visited page last month was News.

Mayor Billy Hewes asked what was driving such a big increase in engagement and traffic to the sites. Ms. Tori Martinez explained that they are boosting posts and ensuring that comments and questions are monitored and responded to.

Supervisor Marlin Ladner asked if anyone had responded to the resident who asked on Facebook what 42% were of. Mr. John Wilson answered that yes, Alan Lane had responded and explained that it was the recycling participation rate.

H. Solid Waste

1. Solid Waste Report

Mr. Alan Lane reported that our recycling participation rate for last month was 43.11% and that our rates are increasing in part due to the new housing developments that are going in because so many of them are putting their carts out.

Supervisor Marlin Ladner pointed out that we would likely see an increase in participation if we could get the larger recycling carts out to our residents. Mayor Jimmy Rafferty asked if the new carts residents get are the larger ones, to which Mr. John Wilson answered no. Mayor Rafferty then asked if it was possible to mandate that. Mr. John Wilson explained that we have been looking at several different ways to do that, but then you would have the neighbors seeing a bigger cart and asking why they can't have the larger carts too. Mr. John Wilson added that we have been looking into grants and funding for larger carts, but because we already have an established recycling program, there is no funding out there for us. Mayor George Bass asked where we were looking, and Mr. Alan Lane answered that we have looked at the local, state, and federal levels, as well as non-profit and private sources.
