F. Executive Director's Report

Mr. Scharr advised the application for the Long Beach Interceptor BP Project was filed with the U. S. Treasury on last Friday. Mayor Bass asked that Mr. Scharr provide the board with a list of all repairs made to the price brothers line and their costs at the next board meeting.

Mr. Scharr provided an update on the Reserve at Carr Bridge and Dogwood Hills. He stated they have completed the work and testing on the water line. The documents have been submitted to the board of health for approval. Once approved it will come back to HCUA to accept the water line. Once the water line is accepted, HCUA can finalize matters with Dogwood Hills.

Mr. Scharr provided an update on the S-14 project. He stated HCUA is awaiting the wetlands permit from the Corps of Engineers. He advised that he is working with Mr. Simpson on a response to the proposed work plan from Jay Bearden.


