Mayor George Bass agreed with what both Mr. Wilson and Supervisor Ladner said but also agreed that maybe this should be tabled until the Board Members can not only look at their own budgets but also have some time to examine and discuss these particular salary adjustments.

Mr. Al Gombos asked what percentage of the proposed FY26 budget these salary increases would be. Mr. John Wilson answered that they would make up less than .03%. Mr. Wilson also noted that every year since 2019 the salary budget for the Authority has gone down, while still giving raises. This is the first year that there will be an increase.
