E2c. FY23 Water Allocations

Mr. John Wilson explained FY23 Water Allocations is part of the budget and the water allocation is divided by six. Mr. Wilson noted that the numbers for water allocation are based on water flow, when solid waste numbers are based on house count and wastewater numbers are based on water flow. The City Long Beach is the only member agency that the water allocation numbers have increased.

Mr. Al Gombos requested clarification if The City of Long Beach, The City of Gulfport and The

City of Pass Christian shared in the sewer allocation for the D'Iberville Wastewater Treatment Plant. Mr. Gombos questioned the HCUA overhead allocation and if The City of D'Iberville's water flow allocation is based on the agencies' participation in flow.

Mr. John Wilson explained the wastewater facilities water allocation numbers are by sewer flow, including the admin numbers and The City of Long Beach, The City of Gulfport and The City of Pass Christian do not share in the water allocation for the D'Iberville Wastewater Treatment Plant, allocation is based on users of the sewer flow at the wastewater treatment plant. The only current flushing is for testing purposes. Approval is required for the water expense part of the budget.
