Supervisor Marlin Ladner requested clarification on whether or not Mr. Wilson felt the \$12,000.00 cost on a revised Solid Waste Plan was worth it, based on what is involved with the paperwork, and if the revisions would include the two landfills and Lamey Bridge. Mr. John Wilson explained that the Solid Waste Plan is a twenty-year plan and updates are required every so often. There are solid waste collections with Pelican Waste and two solid waste collections with Waste Management. The two landfill expansions are already permitted. The City of Gulfport has a new collection contract. Solid Waste revisions are submitted to the Engineer who then makes updates in rewriting the submittal, the submittal is reviewed, approved, and then submitted to MDEQ. The charge is not to exceed \$12,000.00. Mayor Andrew "Fofo" Gilich requested clarification, on whether or not, the calculation for the Engineering fees were based on an hourly rate and if the engineering services were annually.

Mr. Wilson explained that the Engineering fees are based on an hourly rate. A Pay Application is submitted to HCUA and the Pay Application is reviewed based on work performed.

Included during discussion of FY24 Budget Proposed Salary Adjustments, Mayor Billy Hewes made motion to table FY24 Budget Proposed Salary Adjustments until Executive Session, seconded by Supervisor Connie Rockco. There was no vote due to Board Member discussion on steps for Executive Session concerning FY24 Budget Proposed Salary Adjustments. It was determined that Executive Session is only required if there is a request about information regarding the salary of a specific employee(s). Mayor Hewes made motion to withdraw motion to table FY24 Budget Proposed Salary Adjustments, seconded by Supervisor Rockco.

Supervisor Marlin Ladner requested clarification whether or not, the change in staff count was a reflection of a reduction in the number of staff. Mr. Wilson explained that the part time employee retired and the retired employee's duties would be handled by current personnel and that the reduction in personnel also reflects a decrease in FY24 salaries compared to FY23 salaries even with FY24 raises.

Mr. Jim Simpson, Counsel explained that the Executive Director submits a budget, including staff raises and the Board approves the Budget based on total FY Budget. The Board does not

set the Executive Director's staff salaries, but Board Members may request Executive Session to discuss salaries proposed.

Supervisor Marlin Ladner requested clarification on whether or not Mr. Wilson was comfortable with adding additional duties of the retired part time staff member to other staff members and whether or not Mr. Wilson felt the staff members would be overload with duties. Mr. Wilson explained he did not feel staff would be overloaded due to additional duties of the retired staff member.
