Mayor George Bass just wanted to ensure that this covers us, Mr. Jim Simpson assured the Board that yes, we are covered from any liability of responsibility, and reminded them that this was a Professional Services contract, not a Construction contract so the range of liability was much less.

Ms. Cindy Breaux explained that they have a three-year contract, with no option to extend, and that there was no law or guidelines preventing the same firm from entering a second, consecutive contract. The contract that we are recommending them for now would be a three-year contract with the option for three, one-year extensions. Mayor Andrew "Fofo" Gilich raised the concern that if we award this contract to WM&O, and then give them the three, one year extensions, then we are looking at having the same firm for nine years, and if that were the case then we would want to ensure that it was not the same team of auditors doing it every year, we would want fresh sets of eyes.
