# G. 2 a – Motion to Proceed on a Resolution from Jim Simpson to Accept the Conveyance without The Reserve and to begin Wholesale for Dogwood Hills

Supervisor Rocko brought before the Board Randy Rigley of the Randal Corporation who has been developing a piece of property on South Carr Bridge Road, the Reserve. As part of the developing of this property water and wastewater lines were installed by the Randall Corp., the Highway 67, South Carr Bridge Road Water Distribution and Wastewater System (the System). These lines were installed in anticipation of residential development of the Reserve.

The Reserve backs into Dogwood Hills Golf Course, which had asked the Reserve to connect to the System to provide a second source of water for them. An agreement was made between Dogwood Hills and the Randal Corp. to facilitate completion of the water lines.

The Randal Corp met with HCUA and decided that HCUA would take over ownership and responsibility for the System up to the subdivision. Once those lines within the subdivision are complete and connected the HCUA will take ownership of those.
