There being a quorum sufficient to transact business of the Authority, Mayor Billy Hewes, representing City of Gulfport, called the meeting to order. The following proceedings were had and done.

#### **B. Public Comments**

Mayor Billy Hewes opened the floor for public comments.

Mr. Eric Wooten with Recycle Resources, LLC approached the board offering services to lease land as a temporary storage for recycling. Mr. Wooten noted the land was issued a Class 1 Landfill Permit by MDEQ in 2018. A brochure was given to the Board for review with design and plan of services.

Mayor Billy Hewes stated Recycle Resources, LLC would need to have discussions with Waste Management, the board would like to review documentation of size, scope, scale, and fees to take under advisement. There were questions from board members regarding the requirements on storage requirements and Waste Management's responsibility for negotiations regarding solution of temporary storage of recycling items. Mayor Hewes concluded a decision did not have to be made this date and Waste Management would be required to negotiate a solution and present solution or options to board for approval.

#### E1b. Waste Management - Recycling Program/Hurricane Sally

Mr. John Wilson recommended to discontinue recycling on curb side and resume services when Pensacola is operational, and Waste Management would resume pick up including any customer stockpile.

Michael Yarbrough, Waste Management, stated 60 tons of recycling currently stored and Emerald Coast MRF anticipating three to three and half weeks until operational.

Mayor Hewes advised moving forward Mr. John Wilson will contact MDEQ for approved options including approved temporary site for stockpile under Act of God/Force Majeure event or Emergency Declaration and any related environmental information from MDEQ. Mr. Wilson should also note any incurred expenses for member agencies or HCUA and inquire if funds available as result on spread of minutes from storm threat. Also, The Focus Group will notify public immediately curb side recycle service will continue as usual. In the event Mr. Wilson encounters any delays, Board will be contacted to schedule a special meeting next week. The Board requested an update by close of business this date of circumstances moving forward.

#### 2. New Business

#### E2a. Proposed 2020 Bond – 2 Resolutions – Approval

Mr. John Wilson reported that the purpose of the 2 Resolutions is to setup rules for offering and HCUA is not currently locked into an agreement on fees with advisors and agents yet.

Ms. Jane Meymardie, Bond Council, explained missed September 3, 2020 deadline if close by November 2, 2020 and anticipating closing December 1, 2020. Ms. Meymardie explained on the existing deals closing only takes place on the first business day of each month and in the Sales Resolution HCUA only has authority to make deal if agency going to save money.

Mr. John Wilson added no current agreement in place to pay cost of fees and Mr. Jim Simpson will prepare and submit resolution of fees for the six or seven advisors/agents working currently for approval. The approval for fees would be presented to the board for approval, if not approved there would be the opportunity for other professionals to submit their proposed fees.

Ms. Jane Meymardie added decisions can be made for member agencies internally regarding bond. Regarding other fees, Ms. Meymardie indicated a resolution with engagement letter indicated, no fee set, but HCUA will pay a reasonable fee for bond services.
